# Essay Content

Essay Title:

## 1. The Main Content of the Training Program

- *What did you learn during the training program?*
- *How did the training program relate to your country's needs?*

I completed the training program in Korea that mainly focused on Strategic Capacity Building of Organization and contribution to development of community. These include Health Policy and development activities as well as the execution of Action Plan. The training fitted to the needs of my country. It is because in my country, Tanzania, there are inadequate secondary and tertiary health service coverage that convince me to increase emphasis on community health.

## 2. Application Process

- *How did you apply the knowledge and experience learned from the training program on your job?*

My assignment began soon after coming back from the short studies attended in Korea, This was follow-up assignment from the course, I joined Multi-Year Policy Development Course with much interest on Project formulation and Preparation of Action Plans. Utilizing my new position (Head Health Sector Reforms), I made special request to the Ministry of Health to form a team (Task force to Develop Community Health Strategy). This team worked under Technical working group on Quality assurance that again reported to my secretariat 'Health sector Reform Secretariat.' I was also appointed a Chairman for the Task force.

The Ministry of Health, has agreed this innovative strategy as an idea to achieve new ways and means that address the challenges of both morbidity and mortality as a key mission in the provision of health care service by combating communicable and non-communicable diseases through the development and utilization of 'Community Health Strategy'(CHS).

This strategy involved the establishment of demand driven forces within the health service delivery system at Shehia level, to ensure quality demand, facilitated by the creation of informed consumers through the development of community health information system, putting consumers in the driving seat. The idea found to work effectively by having in place a special committee Shehia Health Custodian Committees (SHCCs) to voluntarily coordinate community health activities between all health programs and health related programs and at the community level.

## 3. Achievements

- *What have you achieved through application of knowledge and experience learned from the training program?*
- *What are the expected development effects derived from the achievements?*

The 'Community Health Strategy' (CHS) empowers consumers to make decisions on priorities and allocation of resources towards health service delivery. The enforcement of the district level as the health service delivery 'entity' that is able and flexible to respond to a community-formulated demand for services (including promotional, preventive, curative and palliative services).

Allowing recipients to have right to take part in the governance of first line health care delivery, it will improve the quality of demand for, and therefore increase the responsiveness, equitability, effectiveness and efficiency of

services rendered. Thus, it will reduce the rate of avoidable morbidity and mortality.

In addition to the effect of cure, the CHS strategy describes the implementation modalities necessary to create a well informed consumer of health services, who has the capacity and communication channels to act as an equal partner at the PHC level to set out strategic directions for service delivery, and is able to sensitize the communities to share the responsibilities to improve health status with the formal Zanzibar health delivery apparatus.

#### **4. Key Facilitators**

- *What are main factors that helped you to achieve the results?*

First of all, the KOICA training helped me to think out a new strategy (CHS) to solve the community health problems. The training program was prepared based on increasing knowledge and skills needed for preparation of policy documents, strategies and Plan of Actions.

My own commitment also makes the Action Plan applicable on the field. Utilizing my new position, as Head Health Sector Reforms and Chairman for Quality Assurance, I could initiate the CHS strategy.

Lastly, starting with Danida that supports my idea for the first time, other partners WHO, UNICEF etc have showed their interest in this strategy. These partner organizations have trained the local staff who were selected as the special committee Shehia Health Custodian Committees (SHCCs). Danida has completed initial exercise in two districts to train about 30 SHCCs. During my personal visit with delegation from the Ministry of Health, KOICA also promised to support community interventions with Performance Based Financing. HIPS, WHO, UNICEF, World Bank and Global Fund agreed to support the CHS strategies by contributing Fund for training as well as by intervening to train the members of SHCCs.

#### **5. Key Barriers**

- *What are the challenges that you faced in achieving the results?*

The SHCC is voluntarily operated by local people. However, the incentives are very small. Usually they get incentives through workshops and seminar attended.

Moreover, to effectively deliver health service through the SHCC which coordinates community health activities at the community level, the volunteers are required to be trained to have a sound understanding of health situation.
